Dean's Ferry Road Access to the Locust Fork River

Just the facts, m'am & sir:

County declines to close Dean's Ferry Road . County plans to erect fence

ISSUE

The issue began in 2007 when angry property owners on and around Dean's Ferry Road, located in the Hayden area of western Blount County, complained to their commissioner, David Cochran. They were desperately tired of the uncaring trespassers vandalizing their property. They sought to have the road closed.

BWWSB

After additional complaints of nuisance behavior by All Terrain Vehicle (ATV) riders, Commissioner Cochran asked for help from the Birmingham Water Works and Sewer Board (BWWSB), across whose property the vandals were entering. BWWSB posted "no trespassing" signs on the boundaries of its property. Unfortunately, the signs did little to resolve the problem.

HEARING

In March 2008 the property owners insisted once again that the Blount County Commission close the road, thereby denying all access. The commission duly held a public hearing March 7th to consider closing the road and "vacating" the property. Vacating the property would terminate the road right-of-way and cause ownership of the land to transfer to the adjacent property owner, BWWSB. The road has been virtually abandoned by the county road maintenance department, but continued to be public, owned by the taxpayers.

Only through a concerned citizen did FLFR become aware of the scheduled public hearing, as listed in official notices in *The Blount Countian*.

At the March 7 hearing, a few FLFR board and members, Birmingham Canoe Club members, and several property owners (for and against the closing) made comments. At the regular commission meeting March 10 the commission postponed a decision until the April meeting.

SEEKING ALTERNATIVES

Between those March and April meetings, FLFR board members talked to property owners, Commissioner Cochran, and the BWWSB property manager, seeking a suitable solution short of vacating the property and denying access.

FENCE

On April 14th the commission voted not to vacate the property, but to close the road with a metal gate and fencing that would stop traffic 1/4 mile from the river. Mr. Cochran even stated his hopes for a park or recreational area eventually at that location with the road reopened.

Although the barrier will discourage irresponsible river users, especially ATV riders, it will also unfortunately make it difficult for responsible users, such as canoers and fisherman, to access the river a quarter of a mile further down the gated road.

IS ALABAMA GETTING "GREENER"?

April is sometimes referred to as "Earth Month" by conservation groups; in Alabama, this April definitely proved to be a good month for Earth.

Alabama's state leaders made some important decisions for our environment and public health this past month and as an all-volunteer, citizen organization that helped advocate for these important changes, the Friends of the Locust Fork River (FLFR) is proud to report them.

LEGISLATURE

In early April, the state legislature voted on two important pieces of legislation that could help move Alabama strides forward toward protecting and managing our natural resources.

PLAN!

Introduced by Senator Kim Benefield (D, District 13), SJR28 was passed forming a "Permanent Joint Legislative Committee on Water Policy and Management". The purpose of this committee is to study and develop the Alabama Water Management Plan that will address the state's long term and short term water resource challenges.

A comprehensive water management plan for Alabama has long been advocated by FLFR's statewide partner organization, the Alabama Rivers Alliance, as part of the Alabama Water Agenda (www.alabamawateragenda.com). The Rivers Alliance hopes to be involved as a stakeholder at the subcommittee level, representing the interests of groups like FLFR.

RECYCLING

In addition to the water resolution, the legislature also passed an important recycling bill. The Solid Waste and Recyclable Materials Act was signed into law on April 16th and will provide new funding for counties, municipalities, and nonprofit community groups to develop or expand recycling programs. The bill will also provide increased funding for the Alabama Department of Environmental Management (ADEM) to clean up illegal dumps and enhance their solid waste management program. Reports confirm that Alabamians recycle less than most other states in the country and produce more trash. This bill, which was advocated by FLFR partner organization, the Alabama Environmental Council, will potentially begin to move Alabama up on that list.

CANCER

The state legislature wasn't the only decision-making body making good decisions in April. At their regular meeting on April 18th the Environment Management Commission, which is the oversight board for ADEM, voted to reduce the risk of cancer allowed into our waterways from 1 in 100,000 to 1 in 1 million. This important public health standard was first introduced in a citizen petition filed by 18 environmental organizations, including FLFR, in the spring of 2007. After more than a year of studying the issue and going through the proper procedures, the EMC made the right decision for protecting water quality and public health throughout Alabama.

FLFR and all of our partner organizations on these efforts are pleased to be able to commend our state leaders for making these important decisions for the long term benefit of our rivers and all of our natural resources.

Another Lovely Day at the Races

ANOTHER WINNER!

FLFR's own Stephen Guesman received the Volunteer of the Year Award at the Alabama Rivers Alliance (ARA) 10th annual Watershed Leadership Conference held on March 14-16 at Camp Beckwith in Fairhope, AL. The Volunteer of the Year Award is given to someone who has gone above and beyond to help the ARA throughout the year. In addition to his volunteer duties as FLFR board member and membership coordinator, Stephen helped the Alliance put on their 2nd annual River Revival music

festival in the fall of 2007 and has helped out with the Watershed Leadership Conference on multiple occasions. According to Alliance staff, "Stephen is always around to help out when called upon and he does it all with a smile on his face and a song in his heart!". ARA is a statewide river advocacy organization that FLFR helped form in the mid-1990's and the two have been vital partners ever since. Meetings Of Note

A rash of meetings we've attended recently. by Nancy Jackson

BWWSB: Sam Howell and Nancy Jackson met with Mac Underwood, general manager of BWWSB, and Jerry Jones, with consulting engineering firm Malcolm, Pernie. We received the requested copy of the updated Needs Assessment, which Underwood said estimates need for a new water source by 2025-2035. Sources to be evaluated include quarries, drilled wells to pump to Lake Purdy, the Coosa, Black Warrior and Locust Fork Rivers. Evaluation of those options will be published in a study due out next spring/summer.

Underwood said the likely scenario will be regional sharing of development and use of any new source.

Other topics included conservation measures, drought, rate structures to promote conservation, and the board's new Cahaba watershed protection policy.

In a follow-up letter we commended conservation, and suggested working with the Alliance for Water Efficiency, and offered to work cooperatively on a Locust Fork watershed protection policy if the board would consider that.

Birmingham Regional Planning Commission representatives met with various water supply stakeholders from

Blount County. Their report was preliminary and lacked some accurate detail. Meetings will include the five counties in the larger Birmingham area, prompted by the Alabama Department of Economic Affairs (ADECA), to help identify projects and secure funding, etc. ADECA also plans to create an Alabama Water System map. Work includes identifying current and future water supplies and demands. Sam mentioned the need for conservation, which had not been especially noted.

A Saving Our Water conference presented by the new Green Resource Center in Homewood gathered a few dozen professionals and lay people interested in water use, including the landscaping industry, but also architects, planners and government officials. Although small, the meeting achieved good networking and brainstorming about conservation, efficiency, planning, etc. We appreciate this effort from the center, currently all-volunteer. You can find out more about the center at www.greenalabama.org.

In sum, the drought of '07 was a wake-up call for some who had taken the lush rainfall of the Southeast for granted. It's progress toward more sustainable use in this area.

Renew Our Rivers Cleanup '08: 1.5 TONS OF TRASH

On May 2 we cleaned up six river crossing sites while one canoe worked instream along the Locust from Church Street to Hwy 31 in Warrior. Dean's Ferry was one of the crossing sites, yielding 900 pounds.

In all, we picked up 2,820 pounds of trash and collected 11 tires (5 from the Warrior Civitans canoe clean up). This total is considerably less than the approximately 9,000 pounds collected from our first ROR clean up in 2005 (along with 20-25 tires). We hope this means 1) we've made a dent in the backlog, and 2) maybe people are throwing out less trash.

WILLING HANDS

Participants included ten folks from Southern Company as part of the company's statewide Renew Our Rivers campaign; two FLFR members;

two Black Warrior Riverkeeper staff members; 39 Hayden High School Beta Club students along with four teachers from Hayden High; five or six members of the Warrior Civitans for the canoe crew, and, last but not least, the Fire Chief of Warrior. What a fine team!

This was the second year of participation for the HHS Beta Club. They will definitely be back next year, and we are very grateful for all their help.

This annual Renew Our Rivers event has gained the attention of communities surrounding the Locust Fork from Cleveland through Warrior. Maybe it's raising some awareness!

We hope to make it even bigger and spread into more areas of the watershed year by year.

SHANE'S WEATHER

CHECK THIS OUT !

Every body needs to check our flfr.org website for Weather by the River, posted by Shane Wilson. Look down near the bottom for the link underlined in blue. Click it to see weather, updated every 10 minutes, inside and outside of Shane and Vicky's home in southwestern Blount County, "5 miles from the LFR". It also has links to local and national weather sites.

For example:

It features dew point, relative humidity, wind speed, times when Sun and Moon appear to rise and set (they don't, of course; it's Earth's rotation, remember?) There's a pie graph of wind direction (a neat way to present it).

According to the site, rainfall at Shane and Vicky's house for this year as of 4/29 was 17.92"; I guess you could call

that Rain YTD and that's not bad compared to last year.

There's daily and monthly rain too, from which I can see that 0.47" rain fell at their house on 4/27-28; a total of 3.63" for April. Monthly is shown in 2 places. As Shane says, "...stuff like river levels, do ya need to water plants, dump the water out of the old bottles on the yard, etc." (He's a clown!)

AND the temperature inside their house was 77.3 F on 4/26, and fell to 63 on 4/29, when he left the basement window open overnight. Haven't you just been dying to know their house temps?

Now isn't that JUST TOO COOL?

Thanks to Shane for this new feature in our already great website — also thanks largely to him. He now posts this very newsletter paper-free for you Webbers.

Sam's Pimento Cheese

3 cups sharp cheddar cheese, coarsely grated
1/2-3/4 cup mayonnaise, Helman's
2-3 TBSP green onion tops, thin sliced
1 tsp Louisiana hot sauce
(2) 4oz jars pimentos, diced (or sliced if preferred)
1/2 tsp Worcestershire, Lea & Perrins
1/4 tsp Black pepper, fresh ground

Put cheese in mixing bowl, drain and add pimento peppers, add green onions, black pepper, and Worcestershire and mix. Add mayo a little at a time to assure desired consistency. Splash with hot sauce. Stir gently. Adjust seasonings if necessary. Suggestion: find some tender cabbage or favorite lettuce and make some pimento cheese roll-ups to take on your next canoe trip down the Locust Fork! Ummmmmmmm...
